The DocuSign Agreement Cloud helps freelancers become tax efficient

The Netherlands has a bustling freelance economy with more than 3.1 million individuals considering themselves as freelance. So, it's vital that they can find employment opportunities.

Amsterdam-based Temper operates an online platform for employment opportunities, matching seekers with their ideal candidates. Yet despite posting more than 8,000 hours of work a week, Temper noticed a dramatic drop off in the number of individuals signing up for a second shift. This was because after completing their initial shift, freelancers had to manually apply for a VAT number from the Dutch tax authorities.

This required freelancers to download, print, complete and mail a VAT application form to Temper, who would manually check and verify each application before submitting to the tax office. It was a time and resource-consuming task – and not to mention environmentally unfriendly.

That's where DocuSign came in.

By integrating DocuSign eSignature into its platform, Temper has dramatically simplified the way candidates make themselves available to the business community.

Are electronic signatures safe?

Electronic signatures are arguably the best way to keep your agreements secure and confidential information secure. For most people, they are as safe – if not more so – than the traditional 'signature on a piece of paper'.

Once you use an electronic signature, you never go back. Here's why:

Be direct

Agreements in need of an electronic signature can land directly in the signer's password-protected inbox. That means no more opportunities for lost mail or vulnerable paper documents to be left lying on top of a desk.

Be authentic

DocuSign ID Verification comes fully integrated with DocuSign eSignature to help you authenticate user identities and minimise forgery. For faster, easier and more secure agreements you can verify identities via government IDs and European IDs; SMS, access codes and phone authentication; knowledge-based authentication and even custom verifications too.

Be transparent

End-to-end audit trails are created for each document throughout every transaction, capturing every change with time and date stamps.

Are electronic signatures legal?

Is eSignature legal in the UK?

Quite simply: yes, it is.

England, Wales and Northern Ireland have legally recognised eSignatures since 2002. And, following the introduction of the eIDAS Regulations in 2016, eSignature can help you to collect electronic signatures in a safe and compliant manner.

Brexit may affect eIDAS' application in the UK however, which we'll look at a little later in this eBook.

But to keep you up to speed, DocuSign will provide regular updates as developments in UK electronic signature law arise.

A few exceptions

There are a few exceptions in the UK where an eSignature isn't legally binding or suitable. Currently, most UK Land Registry deeds can't be electronically signed, while electronic signatures are only valid for wills or power of attorney depending on certain use cases - so it's worth double-checking.

Why does eIDAS matter?

You might have seen the word "eIDAS" crop up before.

eIDAS stands for Electronic Identification, Authentication and Trust Services, and is an EU law that oversees electronic identification and trust services for electronic transactions in the European Union's internal market, including electronic signature transactions. It creates a predictable regulatory environment for easier cross border business.

eIDAS went into effect 2016 and is valid across the EU. Its creation helped eliminate ambiguity around the legal value of an electronic signature in the EU, allowing electronic signatures to be admitted in court as evidence and confirming that they cannot be denied legal effect because they are in electronic form.

Three different options

Just like running a business, one solution doesn't fit all. eIDAS provides three different signing options: Standard, Advanced, and Qualified. Each option provides different levels of assurance – and in turn, compliance – to the requester. Here's what each tier entails:

Standard electronic signature	A standard electronic signature covers most electronic signatures. It can be applied to a document as the evidence of the signer's approval or acceptance.
Advanced electronic signature	An advanced electronic signature adds extra layers of security to a Standard Electronic Signature so that it provides a higher level of signer ID verification, security and tamper- sealing. This includes requirements that uniquely link an electronic signature to the identity of the signer.
Qualified electronic signature	A qualified electronic signature has a special legal status in EU member states and is the legal equivalent of a written signature. It must meet the highest security measures and be backed by a qualified certificate. The signer's identity must be verified and vouched for by a trust service provider that is certified by an EU member state. Due to these stipulations, QES can be impractical for everyday use.

Future-facing

eIDAS has revolutionised the way EU member states interact with one another in the world of business, and beyond.

Its framework sets the standard for electronic identification and authentication. And, as the EU pursues its mission to create a single, digital society, elDAS' potential to centralise and standardise the way in which different nations interact looks to be further boosted.

The elDAS Regulation sets the precedent for future digital transformation and is helping to further regulate and encourage a level playing field for digital signatures, identity recognition, and more, across the EU.

elDAS after Brexit

The UK officially left the European Union on 31 January, 2020. In a post-Brexit world, there are many agreements and new procedures outstanding - including how eIDAS will function.

It's likely that the eIDAS Regulations will be replicated in UK law following Brexit, regardless of whether there is a managed exit from the EU or not. EU Regulations relating to electronic signatures - including eIDAS - will continue to apply until 31 December 2020.

DocuSign will provide ongoing updates throughout the Brexit transition period if regulations look set to change.
